N O T I F I C A T I O N

Consequent upon amendment of Panchayat Laws of Orissa in consistent with 73^d amendment read with article-243-G of the Constitution of India. Govt. have been pleased to assign definite functions and provide functionaries to PRIs for implementation/ execution of functions. The filed functionaries of this Deptt. are to exercise their duties and responsibility according to the Activity Mapping & they are accountable before the 3-tire PRIs as per devolution of power as detailed below.

1. District Welfare Officer will remain accountable to the Zilla Parishad for primary education activities of ST & SC Dev. Deptt.
2. Casual leave of District Welfare Officer will be sanctioned by the Chief Executive, Zilla Parisad. The District Welfare Officer will sanction casual leave of other officers under him.
3. President can report about performance of duties by the District Welfare Officer to the Head of the Department for appropriate action
4. Welfare Extension Officer (WEO) will remain accountable to the Panchayat Samiti for activities assigned to him.
5. Sarapanch and Chairman, Panchayat Samiti can visit Sevashrams, give suggestion for improvement and report about performance of duties by the Welfare Extension Officer and Sevashram teachers. The report will be sent to the Project appropriate action. There shall be village level committee to over-see the performance.
6. Sarapanch shall sanction casual leave of only Headmaster/ I/C Headmasters of Sevashrams. The Headmasters would be competent to sanction casual leave to the Assistant Teachers of Sevashrams.
