

OFFICE ORDER

Considering the views offered by GA Deptt. in respect of the representations submitted by the regular teaching staff working under ST & SC Development Deptt. Schools and who have been regularized earlier vide ST & SC Development Order No. 31851 dated 24.11.2014 and No. 7885 dated 10.4.2015 w/r to GA Deptt. Resolution No. 26108 dt. 17.9.2013 and considering further proposals submitted by the District Welfare Officers Boudh and Gajapati in regard to regularization of Services of the teaching staff in terms of Resolution No. 13627 dated 8.4.2013 issued by ST & SC Development Deptt., the High Power Committee recommended 5 (five) cases of teaching staff for regularization of their services in terms of the Resolution No. 13627 dated 8.4.2013 instead of the GA Deptt. Resolution No. 26108 dated 17.9.2013.
