Minutes of the meeting of the State Level Committee on Prime Minister's new 15-point programme for Minority Communities held in the 2nd Floor Conference Hall of Secretariat on 09.01.2012 at 10.30 A.M.

The State Level Monitoring Committee of Odisha review meeting on Prime Minister's New 15-Point Programme was presided over by Sri B. K. Pattanaik, IAS, Chief Secretary, Odisha. The list of members attended the meeting is annexed at "Annexure-1".

The Commissioner-cum-Secretary to Govt. of Odisha, ST & SC Dev. and Minorities & Backward Classes Welfare Deptt., briefed on objectives of the programmes as well as implementation of identified Schemes for minorities and minority concentrated areas, followed by a PowerPoint presentation.

1. Proceeding of the review of the Compliance/ Action Taken Report of Administrative Deptt. on decisions of previous SLC meeting held on 10.02.2011 was confirmed.

2. The status on 15 point programme implementation and further directions on certain programme suggested and discussed are as given bellow.

3.1. Equitable availability of ICDS Services :

Enhancing opportunities for education

Apart from the focus on 15 Minority concentrated blocks in 4 Districts, It was decided that Anganwadi Centres should be established in other minority concentrated pockets both in Urban as well as Rural areas. The Deptt. of W and CD should inform regarding the no. of Anganwadi centres sanctioned and made operational in Minority concentrated urban and rural pockets.

3.2. Improving access to school Education :

More and more schools are to be opened to provide access to those out of school children of minority communities. If necessary the possibility of engaging a Community Resource Person/ Animator from among the community to encourage enrolment and retention may be explored. The School and Mass Education Deptt should examine this as part of the Alternative Innovative Education (AIE) and take further action.

3.3. Greater resources for teaching Urdu :

Steps should be expedited for appointment of 25 Urdu teachers for whom Gol has released funds.

3.4. Modernizing Madarsa Education :

(a) It was informed that funds have not been sanctioned by MHRD under the Scheme for Providing Quality Education in Madarsa (SPQEM) by Govt. of India. The concerned CI of Schools who had received allotment are yet to furnish UC and it was decided that a review meeting under the Chairmanship of DC-cum-ACS shall be taken up in this regard.

(b) Mr. Md. Ekin expressed that during his visit to Cuttack he found the condition of the Urdu girls High School, Odia Bazar, Cuttack to be very poor and it is in dilapidated

condition. Chief Secretary advised to seek an inquiry report from the Commissioner CMC and action should be taken immediately.

3.5. Scholarships for Meritorious students from Minority communities:

All scholarship should be Bank linked and the committee observed that electronic fund transfer of scholarship amount to bank account of minority students should be introduced by opening of zero balance account.

3.6. Improving educational infrastructure through the Maulana Azad Education Foundation :

Administrative Deptt. should take care of wide publication in press media as well as electronics media. The educational institutions should be sensitised well in advance through career counselling desks so that more and more minority girl students shall get the benefit in future.

3.7. Self-Employment and Wage Employment for the poor :

The committee requested that concerned Department should concentrate on schemes under Swarna Jayanti Gram Swarozagar Yojana (SGSY) to be streamlined further with awareness and support in all minority concentrated villages and urban localities for their easy access. The Panchayati Raj deptt. should also maintain a database regarding the number of minorities being covered under different wage employment as well as developmental programmes.

3.8. Up-gradation of skill through technical training :

Committee advised the Special Secretary, Industries Deptt. to take immediate steps for administrative approval for the estimate submitted by IDCO and to expedite the construction work within the current financial year of the two ITI buildings at Guma & Mohana Block to be constructed under MsDP scheme.

3.9. Enhanced credit support for economic activities :

A separate meeting under the Chaimanship of DC-cum-ACS shall be taken up for placement of share capital assistance to OBCFDCC by Finance Deptt. for betterment of poor minority people.

3.10. Recruitment to State and Central Services :

Principal Secretary, Home Deptt. briefed that there is no such provision in the said recruitment Rules/ Draft Cadre Rules to nominate one member of minority community in the selection board for the recruitment of police personnel.

3.11. Equitable share in rural housing scheme

It was decided to make all out efforts to cover the BPL minority families of identified villages under IAY. The Collector, Gajapati requested that more than 4000 BPL minority families are to be covered in Gajapati district and therefore, additional allocation under IAY @Rs.48500/ per house should be requested from the MoMA. He was requested to send the required proposal.

3.12 Improvements in condition of slums inhabited by minority communities :

The Joint Secretary, H & U.D Deptt. briefed that instruction has been issued by R & DM Deptt. to all Collectors to issue caste certificate to slum dwellers under prescribed guidelines. 768 minority beneficiaries covered under IHSDP Scheme of which 418 dwelling units are in progress with an expenditure of Rs.303.24 lakhs. DC-cum-ACS advised to give the target and achievement of different welfare measures being undertaken in different ULBs during the next meeting.

3.13. Prevention of communal incidents :

All Collector & D.Ms and Superintendent of Police have been alerted for the prevention of communal tension as it is one of the prime duties. No incidence relating to communal tension has been reported in the recent past.

3.14. Prosecution for communal offences :

Principal Secretary, Home Deptt. briefed that till date the progress of prosecution and conviction in Kandhamal riot cases have been much higher than National average and the process has been expedited through setting up of Fast Track Courts and deployment additional Public Prosecutors.

3.15. Rehabilitation of victims of communal riots :

All the riot victims who had taken shelter in relief camps have returned to their villages and camps have been closed.

Agenda No. 4. Other Points:

a. **Multi Sectoral Development Programme (MSDP):** The status and progress on implementation of Multi Sectoral Development Plan for Gajapati District was presented by Collector, Gajapati. The DC-cum-ACS advised the Collector to complete the two ITIs buildings under MsDP at the earliest. The other components sanctioned under MSDP should also be expedited.

b. M & BCW Deptt. is to chalk out a detailed strategy on streamlining the different organizations involved in different development programmes for Minorities and put up a proposal to bring them under one umbrella.

Meeting ended with vote of thanks to the chair.
