PROCEEDING OF THE SC WELFARE ADVISORY BOARD MEETING HELD ON 22.09.2010 AT 11.00 A.M. IN THE THIRD FLOOR CONFERENCE HALL OF SECRETARIAT

The list of participants is at Annexure-A.

The meeting of the Scheduled Castes Welfare Advisory Board under the Chairmanship of Hon'ble Chief Minister was held on 22.09.2010 at 11.00 A.M. in the third floor Conference Hall of the Secretariat. At the outset Principal Secretary, ST & SC Development Deptt. extended a warm welcome to the Hon'ble C.M., Hon'ble Minister, ST & SC Development, esteemed members of the SC Welfare Advisory Board, Chief Secretary, APC-cum-ADC and other Govt. officials representing various other departments.`

The following decisions were taken in the meeting in respect of different items of the Agenda.

Item No. 1. Confirmation of the last meeting held on 23.04.2008.

The proceeding of the last meeting of the SC Welfare Advisory Board, which held on 23.04.2008, was confirmed as *no comment* was received from any quarters.

Item No.2. Action taken on the proceeding of the last meeting held on 23.04.2008.

The Principal Secretary, ST & SC Development Deptt, then presented the action taken report on the proceeding of the last meeting and the following decisions were taken:

2.1 The Govt should take expeditious steps for making necessary amendment of the existing ORV Act.

(Action – ST & SC Dev. Deptt.)

2.2 Steps would be taken to take appropriate amendments in the ORV Act. in case of contractual appointments in respect of posts which are likely to be regularized subsequently.

(Action – ST & SC Dev. Deptt.)

2.3 Health & Family Welfare Deptt. will place a report before the next Advisory Board as to whether the Class-III posts of Ayurvedic & Homeopathic Medical Officers which have been upgraded to Class – II have followed ORV Act. while filling them up at the entry point.

(Action – H & F.W. Deptt.).

Item No.3 to 5: PCR & POA Act, Sanjog help line &incorporation of syllabus in different recruitment examination

3.1 Hon'ble Members raised their concern for slow disposal of cases filed under PCR & POA Act., D.G., Police informed that between July to September, 2010 from 2689 pending cases the number has been reduced to 1990 cases and he expected that the number will be further reduced to 1,000 by end of December 2010. Hon'ble Chief Minister ordered to fix deadlines for completion of investigation of pending cases.

(Action – Home Deptt./D.G.&I.G. of Police)

3.2 Principal Secretary, ST & SC Development Deptt. informed the House that Sanjog Help Line has been set up as a means of grievance redresal under PCR & POA Act. It was decided that steps will be taken to inform the complainants about the steps taken on the complaint on case to case basis.

(Action – ST & SC Dev. Deptt.)

Item No. 6. - Rehabilitation of identified Manual Scavengers:

For left out scavengers under the rehabilitation scheme, an advertisement in the daily News paper will be made inviting applications from the left out persons if any who will be then covered after due verification within a stipulated time frame so that the State be declared as a manual scavenger free state.

(Action – ST & SC Dev. Deptt.)

Item No-7. Construction of SC Hostel:

Earlier 10% of seats in all the Hostels constructed for ST students are earmarked for SC students. Now more percentage of reservation of seats will be available for SC students taking into account the SC population within the district.

(Action – ST & SC Dev. Deptt.)

Item No8. Pre Matric & Post Matric Scholarship;

8.1 Since there is no provision of scholarship for ST & SC students reading from Class-I to Class-V while the same benefit is extended for the OBC & Minority students, State Govt. will move Govt. of India for providing financial assistance to extend scholarship to SC/ST students from Class-I to V at par with OBC Pre-Matric Scholarship rate.

(Action - ST & SC Dev. Deptt.)

8.2 Scholarship will be made inflation linked and there will be a revision once every year. This will be examined by Finance Department before giving a final view in this matter.

(Action – Finance Deptt.)

8.3 Arrear Pre-Matric Scholarship should be cleared in all districts till 2009-10 and cases of misappropriation of scholarship should be sternly dealt with.

(Action – ST&SC Dev. Deptt.)

Item No 9. Proposals pending at GOI for inclusion of SC Communities in the list of Orissa;

A sub-committee of the SC Welfare Advisory Board will meet the Hon'ble Union Minister, Social Justice & Empowerment at New Delhi to apprise about the pending proposals for inclusion of communities in the SC list of Orissa. Hon'ble Chief Minister may discuss with Union Minister during his tour to New Delhi.

(Action – ST & SC Dev. Deptt.)

Item No.10 to 12. Inclusion of "GIRIGIRIA", "KUMBHAR" & "MAHARA caste in the list of Scheduled Caste:

The proposal for inclusion of Girigiria, Mahara and Kumbhar community in the SC list of Orissa was deferred to the next Advisory Board Meeting and it was decided that the joint report submitted by SCSTRTI and NKCDS will be further examined by Administrative Department and will be placed with suitable suggestions before the SC Welfare Advisory Board.

(Action – ST & SC Dev. Deptt.)

Item No. 13 &14. Recommendations received from Home Deptt. & Orissa State Legal Services Authority:

These matters could not be discussed.

Item No. 15. Proposals from Shri Arjun Charan Sethi, Hon'ble M.P.

15.1 Panchayati Raj Deptt. will examine the matter raised by Shri Arjun Sethy, Hon'ble M.P. regarding construction of market complex on Govt. land and its allotment in favour of SC allottees under the guidelines of SGRY in Bhadrak and inform Hon'ble M.P. accordingly within a month.

(Action – Panchayati Raj Deptt.)

15.2. School & Mass Education Deptt. and D.I. of Schools, Bhadrak is to take expeditious steps for vacating stay order in the appropriate court.

(Action – S & M.E. Deptt/D.I. of Schools, Bhadrak).

15.3. The list of persons appointed by the Chief District Medical Officer, Bhadrak along with orders of the Hon'ble High Court may be supplied to Hon'ble M.P. within a month.

(Action – H & FW Deptt./CDMO, Bhadrak)

Irem No.16. Proposals from Shri Jogendra Behera, Ex-MLA.

16.1. Law, H&FW, Industries and ST&SC Dev. Deptts. will examine the issue about reservation of seats (22.5% seats for STs and 16.25% seats for SCs) for students in Professional Colleges and higher education institutions including private Colleges/ Universities. Free coaching may be given for SC and ST students in reputed coaching institutions for admission in professional colleges. ST & SC Dev. Department will formulate a scheme in this regard.

(Action- Law, H&FW, Industries and ST&SC Dev. Deptts.)

- 16.2. Fisheries & ARD Deptt. will take steps for sanction of pension & family pension in favour of Sri Ramachandra Behera, Junior Fisheries Officer retired since 31.08.2000 within a month. (Action- F& ARD Deptt.)
- 16.3. S & M.E. Deptt. agreed to take expeditious steps for sanction of pension in favour of Sri Sarangadhara Sahoo, Teacher of Gandia Block in Dhenkanal dist. within a month.

Item No 17. Any other matters.

17.1. Esteemed Members raised the issue of loan waiver of beneficiaries financed by OSFDC. Information from other SC dominated States should be collected on the matter, which will be examined and placed before the next SC Welfare Advisory Board. Govt. of India, Ministry of Social Justice & Empowerment may be moved for waving of agricultural loans availed by SC/ST loanies under OSFDC.

17.2.Revenue & D.M. Deptt. will issue clarification regarding issuance of residence certificate in favour of persons residing in urban areas having no proof of document of their land in urban areas. Wide publicity may also be given on this matter. (Action – Revenue & D.M. Deptt.)
