

## Proceedings of the meeting of Tribes Advisory Council Held on 09.01.2009

The Tribes Advisory Council meeting was held on 09.01.2009 at 11:00 AM in the Third Floor Conference Hall of Secretariat under the Chairmanship of Hon'ble Chief Minister, Orissa. The list of Hon'ble Members and Officers who attended the meeting is annexed – Annexure –I.

At the outset, welcoming all the Members of the TAC, Hon'ble Chief Minister requested the Members to discuss various issues Agenda wise and put-forth their valuable suggestions/opinions to take decisions on each Agenda.

Commissioner-cum-Secretary, ST & SC Dev. Deptt. placed the Agenda items for discussion with explanatory notes before the august house.


After detailed deliberations on various items contained in the Agenda the following decisions were taken agenda wise unanimously.

1. The proceeding of the last Tribes Advisory Council meeting held on 28.12.2007 were confirmed by the Council.
2. The compliance report of the decisions taken in the last Tribes Advisory Council meeting was placed before the Hon'ble members and was approved.
3. The Council went through the agenda note as well as the addendum to the agenda note on the subject. After a threadbare discussion, it was observed that no non-tribal can be permitted to get Scheduled Tribe Certificate on the ground of speaking Kui language. The Council noted that over a period of time, 'Kui' has acquired a social identity of the Kandhas, specially in Kandhamal District. It is therefore, unanimously decided to recommend to Government of India to substitute "Kui" by "Kui Kandha" at Serial No. 31 of the Presidential Order of the Orissa Scheduled Tribes list keeping all other entries at Sl. 31 unchanged.
4. The proposed draft amendment of the Regulation 2 of 1956 with the changes desired by His Excellency, the Governor of Orissa and vetted by the Law Deptt. was placed before the Council and the same was approved.
5. The Annual Administration Report for 2006-07 regarding Administration of Scheduled Areas was placed before the Tribes Advisory Council and it was approved.

6. The proposal of Dr. Giridhar Gamang, Hon'ble M.P and member of Tribes Advisory Council regarding Regulation-2 of 1956 was discussed and it was decided to conduct an empirical study by an independent Agency to assess the impact of Regulation-2 of 1956 on the tribals. Rest of the proposals raised by Hon'ble member and M.P., Sri Giridhar Gamang were clarified as stated in the agenda notes.
7. The proposal of Shri Bhagirathi Majhi,, Hon'ble MP and Member, TAC for award of Scholarship/Stipend to the students for each successive years of higher education till the completion of the course, subject to good conduct and regularity in attendance on renewal basis for continuing the studies in the same colleges /institutions without production of caste certificates for each successive years was approved. However, in case of specific complaints/allegations, it should be looked into.
8. The proposal to recommend **inclusion of DELKI KHARIA (DELKI)** in the Presidential Order of Orissa scheduled Tribe list at Sl.No. 29 was approved. Rest of the proposals raised by Hon'ble Member, TAC and M.P., Sri Bhagirathi Majhi and the response submitted by the Department on them were noted.
9. Regarding the point raised by Padmashree Tulsi Munda, to remove ambiguity between "Sabar" and "Saara" (ଶାଆର ) it was clarified that according to clarification of Hon'ble Supreme Court, no body has the power to any interpretation of synonyms in the Presidential order. Therefore no action can be taken on this at the present stage. The request may be repeated to Government of India; if already made.
