Proceedings of the meeting of the State Level Monitoring Committee on implementation of Tribal Sub-Plan (TSP) and Scheduled Caste Sub-Plan (SCSP) during 2010-11, held on 19.04.2011 at 4.00 P.M. in the 2nd Floor Conference Hall of Orissa Secretariat.

- 1. The Development Commissioner, Orissa presided over the meeting.

 The list of members alongwith the other officials, who attended the meeting is at Annexure.
- 2. At the outset, the Commissioner-cum- Secretary, ST & SC Development Department-cum-Member-Convener made a power point presentation.
- 3. A comparative statement of the overall State Plan Provision, flow to TSP/ SCSP, expenditure during the years 2007-08, 2008-09, 2009-10 and 2010-11 was presented alongwith expenditure under TSP during 2010-11 which was 21.76% of the net provision.

So far the expenditure under flow to SCSP is concerned the percentage is 12.76% during 2010-11 against 14.73% during 2009-10 12.50% during 2008-09 and 17.45% during 2007-08. However, the above figures are provisional as final figures for the period ending 31st March were still being compiled.

- 4. Department-wise provision of funds, flow to TSP/ SCSP and expenditure thereof during the year 2010-11 was reviewed.
 - (a) The D.C. advised to take stock of the matter and steps may be taken by the concerned Departments for making provision under intimation to P & C Deptt. and ST & SC Dev. Deptt.
 - (b) He further observed that IT Deptt. should also indicate flow under TSP/ SCSP considering such an allocation of Rs.9844.00 lakh.

- (c) The net provision of Energy Deptt. is Rs.150278.45 lakh including Rs.99000.00 lakh under P.S.U. Schemes and proportionate flow to TSP/ SCSP has not been indicated under PSU Schemes.
- (d) In case of any doubt, ST & SC Dev. Deptt. may be consulted.
- 5. (a) The Development Commissioner observed that the Departments should reconcile the reported expenditure again and submit both the financial and physical achievement scheme-wise to ST & SC Dev. Deptt. immediately.
 - (b) It reveals that as many as 19 Departments have incurred expenditure less than the State average of 21.76% and the remaining 7 Departments have utilized funds more than that of the State average ranging from 21.82% to 91.09% of their net provision.
 - 6. (a) A sum of Rs.1552.58 Crore has been reported to have been utilized during 2010-11 under SCSP which is 12.76% of the net provision,
 - (b) 12 Departments have utilized funds less than that of the State average of 12.76% of the net provision.
 - (c) Remaining 14 Departments reported expenditure from 13.39% to 38.59% of their total allocation.
 - 7. The areas of concern in allocation of funds scheme-wise and implementation the programmes under TSP/ SCSP were highlighted.



The following decisions were taken after the discussion:

- a. All the Departments should reconcile their reported financial and physical achievement up to 31.03.2011 and submit the revised report to ST & SC Dev. Deptt. immediately.
- b. All Departments should prepare a district wise, scheme-wise financial and physical provision and achievement and report to the P & C as well as ST & SC Dev. Deptt..
- c. A report pertaining to provision, expenditure, shortfall and reason of shortfall is to be provided by all Departments to ST & SC Dev. Deptt. and P & C Deptt.
- d. District sector schemes should be identified by the District Level Committee.
- e. All the District Level Officers will be the members of District Level Committee.
- f. TSP/ SCSP documents should be prepared by end of April.

The meeting ended with a vote of thanks to the Chair.
