## MEMORANDUM

Sub: Self -Certification at the time of applications only for availing various services under ST & SC Dev. and M & B.C.W. Deptt, subject to verification of originals during actual admission, personal appearance or engagement etc.

For promoting citizen centric Government, it is necessary to simplify the official procedure. In the present systems of applications of citizens to avail different services, they are facing a lot of problems in submitting attested copies, affidavits, etc. even during the application stage, causing inconvenience to citizens.

2. Therefore, it has been decided that at the time of submission of the applications by the applicants for following purposes under ST & SC Dev. And M & B.C.W. Deptt., the applicants need not submit any attested copies of documents or any form of affidavits along with applications. They need only to submit self-certification of documents where ever required with a written declaration included at the end of application form. The copy of the format of self-declaration is annexed at Annexure- A & B (English & Odia) to be used for the following.

Admission of students in SSD Schools & Hostels. a.

b. Admission to C.T./ B.Ed. Courses.

c. Application for grant of different types of scholarship.

d. Engagement of Sikshya Sahayak.

e. Engagement of contractual Teaching & Non- Teaching staff.

f. All contractual engagement in Govt. Deptt./ Local Bodies under ST & SC Dev. Deptt.

3. Under self-attestation method, the original documents are required to be produced during actual admission, personal appearance or final stage of engagement, etc.

In case of concealment or misrepresentation, legal action will be taken among others under relevant section of IPC.
