RESOLUTION

The 7th June 2013

Subject—Implementation of OTELP PLUS in Mayurbhanj district.

OTELP PLUS will be implemented in Thakurmunda, Suliapada & Jashipur Blocks of Mayurbhanj district from the year 2013-14. The programme aims to promote Integrated Development of the poor Tribal people living in programme area and would support land and water management, sustainable management of forest and Development of Agriculture & Horticulture on watershed basis with the active involvement of the user community & stake holders.

- 2. After careful consideration Government have decided that—
 - (i) The Programme Administrator of ITDA, Karanjia will be primarily responsible for implementation and review of the progress of the programme at the field level.
 - (ii) The PA, ITDA shall have the same functional power and responsibilities in relation to the programme at the district level as the Programme Directorate has at the State level.
 - (iii) For the purpose of the programme ITDA shall endeavour to strengthen its autonomy on a registered sociality expanded to permit it to operate Bank A/c, hire staff from Government or the open market and establish independent Financial and personal policies.

- (iv) ITDA shall establish a management committee chaired by the District Collector to provide regular management support including the Review & Monitoring of Programme implementation.
- (v) ITDA shall be responsible for implementing the programme activities in its districts including submitting monthly/Annual progress report to the PSU for social mobilization, capacity Building and participatory planning activities. ITDA shall enter into contract with facilitating NGOs. if PSU and ITDA jointly determine that no suitable NGO is available for carrying out the above activities, the State shall allow the ITDA to be involved in implementing such activities.
- (vi) ITDA shall enter into an agreement in the prescribed format with each VDC in the programme village in the district for programme implementation and transfer of loan proceeds. The format shall be prepared by the PSU. After sign the MoU, Programme Director shall authorise the release of funds through the ITDAs programme, A/c to the relevant VDC programme, A/c in accordance with the Annual Work Plan Budget. The accrued interest shall remain in the ITDA programme A/c. No MoU shall be amended and modified without prior consent of PSU.
- 3. In addition to the above the PA, ITDA shall have exercise the power as provided in the Programme Implementation Manual (PIM)
