The remuneration of all the employees of PSU Headquarters are to be fixed as per recommendation of the Rationalization Committee meeting held under the Chairmanship of Development Commissioner on 15.02.2011 and observation of Finance Department vide their U.O.R No. 111-SS-II dt. 18.03.2011 in File No. SP (IFAD)-1/2011 of this Department.
- 4. The qualification for the above proposed posts are to be determined by this Department as per the recommendation of the meeting of the Rationalisation Committee held on 15.02.2011 under the Chairmanship of Development Commissioner.
- 5. All these posts in OTELP Plus except the Programme Director shall be purely temporary and coterminus with the period of Schemes and under no circumstances shall be regularized. Personal liability will be fixed on the officials responsible for continuance of these people after expiry of the scheme.
- 6. Undertaking from the Contractual Staffs / Outsourcing Staffs at the time of their engagement that they will not claim for regularization in future shall be obtained.
- 7. No further engagement in OTELP Plus in PSU Headquarters and at field level of ITDAs be made without concurrence of Finance Department.
- 8. Continuance of staffs working in PSU at Headquarter and field level of ITDAs be made on the basis of review on their performance annually by it this Deptt.
- Govt. Order in this regard has been taken by Finance Deptt. in their File No. FIN-SOS2-MISC-0004-2015.

You are therefore requested to please take necessary follow up action on the matter strictly as per the stipulations of Finance Deptt. as mentioned above under intimation to this Deptt. and to all concerned.
