Sub: **Coverage of FRA beneficiaries under Govt. Schemes through convergence mode and particularly those relating to land improvement, land productivity etc. under MGNREGS.**

Madam / Sir,

I am to say that Covid-19 & lock-down measures have affected the lives and livelihoods of the STs **and** particularly those residing in & around the forest areas of our State. Till February, 2020, about 4.38 lakh ST families have been vested with forest land under the Forest Rights Act, 2006, but it is noted that only 61 % of them have been registered under MGNREGS till the first week of May, 2020 and a negligible number have been provided with works. This is despite our instruction to ensure coverage of all FRA title holders under MGNREGS vide letters referred above. District wise details are attached herein as **Annexure-1** for your information and immediate action.

I would therefore, request you to look into the matter personally and to ensure that all the FRA title holders are registered under MGNREGS & wage employment as well as livelihood opportunities are provided to them for their betterment & well being so as to provide them succour at this critical juncture.

This may please be treated as **URGENT**
