Sub: Effective implementation of the STs & Other Traditional Forest dwellers (Recognition of Forest rights) Act, 2006 by extending hand holding support to the eligible claimants as well as capacity building of Govt. functionaries, PRI members and other stake holders.

Madam /Sir,

It is to inform you that the Scheduled Tribes & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (FRA) is being implemented in our State since the year 2008 and to bring further efficiency into its implementation, clarification is issued on the points raised in the Collector's VC dtd.14.11.2019.

1. Engagement of retired RIs/Amins etc. on contractual basis has already been permitted vide this Department letter no.38848/SSD dated 06.11.2008 (Copy enclosed as **Annexure-1**) and the expenditure in this concern is to be met out of funds under Article 275 (1) of the Constitution. However, the consolidated remuneration to be paid to the retired Govt. servant (Amin, RIs etc.) is to be guided by the instructions contained in the Office Memorandum no.7022 /F dated 17.03.2018 of the Finance Department.
2. It may also be noted that till the end of March, 2019, a total sum of Rs.1844.05 lakh under article 275 (1) has already been allotted to the districts concerned (Year wise, district wise position are indicated in **Annexure-2**) for implementation of FRA and requirement for the current financial year has been

sought vide this Deptt's letter dt.25.07.2019 & reminders thereafter, which, till date, have been received from 16 districts only. However, fund, as sought for in this concern through the prescribed format by the districts are being processed & would be placed soon with the concerned districts.

3. Collectors may also engage NGOs/ CSOs working through their network of NGOs in several districts in providing capacity building training to Forest Rights Committees (FRCs), Sub-Divisional level Committees (SDLCs) & Govt. officials associated in the process of implementation of FRA. You may locate such NGOs in coordination with the ITDAs.



Sub: Engagement of retired Revenue Inspectors/ Amins on contractual basis for implementation of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act 2006 and Rules 2008 in the State.

Sir / Madam,

I am directed to say that it has been decided in the meeting Dt. 01.11.2008 chaired by Hon'ble Chief Minister, Orissa that each Sub Collector may be permitted to engage services of a maximum of ten Revenue Inspectors/ Amins who have retired from Govt. service on a contractual basis, for a period of 3 months, which will help in better implementation of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 and Rules, 2008. Such personnel will help in preparation of maps for early finalization by the Sub Divisional Committees.

You are, therefore, permitted to incur expenditure in engaging services of maximum ten retired Revenue Inspectors / Amins on contractual basis, for a period of 3 months at the consolidated remuneration of Rs. 3500/- per month for a retired R.I. or Amin, for the purpose. Such expenditure may be met out of funds under Article 275(1) of the Constitution. Funds will be released after receipt of the requirement from you in this regard.

Action taken in the matter may please be reported to this Department at the earliest convenience.
