**OFFICE ORDER**

- a) The recent Caste Certificate from the Competent Authority

- b) A Certificate of Fitness from a Medical Officer not below the rank of Asst. Surgeon of any Govt. Hospital
- c) Character Certificate from two Gazetted Officers
- d) Two passport size photographs duly attested by Gazetted Officers
- e) Marital status Certificate, if married having not more than one spouse living
- f) A declaration in writing to the effect that he/she is not attending any Educational Institutions for higher studies






