

**Proceedings of the meeting held on 08.09.2014 at 11 A.M. to finalise the
ATR on the decisions of the 7th SLMC on FRA held on 27.06.2014.**

The meeting to finalise the action taken report on the decisions of the 7th SLMC on FRA (held on 27.06.2014) was held on 08.09.2014 at 11 AM in the Conference Hall of the SSD Department under the Chairmanship of the Commissioner-cum-Secretary, ST & SC Development Department, Odisha. List of Members present in the meeting is attached herein as Annexure-1. After detailed discussions on the 10 points minutes of the meeting dt.27.06.2013, following decisions were taken:

1. **Guideline for creation & maintenance of Permanent Register:** The detailed guideline for reflecting individual & community rights in the permanent registers maintained by the DFOs is to be communicated by the PCCF, Odisha to the SSD Department by 22.09.2014

(Action: PCCF, Odisha / F & E Deptt., Odisha)

2. **Issue of Titles with sketch Maps:** All Collectors were requested to furnish detail data as per the format indicated below by 22.09.2014.

3. **Issue of instruction for creation of irrigation potential for FR Title Holders:** Panchayati Raj Department has already issued instructions to all Collectors to maximise creation of irrigation potential from MGNREGA. However, detail database / information in respect of all the FR Title holders are to be furnished by the PR Department as per the source & type of irrigation so that further interventions through other livelihood promotion schemes of the Govt. could be converged. The information from PR Department should reach the SSD Department by 22.09.2014.

(Action: PR Department / All Collectors)

4. **Coverage of all FR Title Holders under MGNREGA:** Till the end of August, 2014, 53835 numbers of title holders, out of the total 336778 beneficiaries distributed with FR Titles, have been covered under MGNREGA which is about 15.9% only, as reveals from the MPRs submitted by the Nodal Officers on FRA. All Collectors were requested to speed-up the process of convergence and ensure that all the title holders are provided assistances through MGNREGA so that their livelihood options could be improved.

5. Preparation of Model Land Development Plans: P.R. Department to ensure communication of the Model Land Development Plan to all Collectors with a copy to the SSD Department by 27.09.2014 for its reference & replication in the field at the respective District level.

(Action: Panchayati Raj Department / All Collectors)

6. Holding of DLC meetings on FRA regularly. : All Collectors are requested to report about the holding of the DLCs during the year 2013 & 2014 to the SSD Department by 22.09.2014 in the following format.

7. Sharing of Template for Development of Conservation & Management Plan: PCCF, Odisha is requested to formulate & furnish the guidelines for preparation of the Conservation & Management plan for Community Forest Resources by the Committees constituted by the Gram-Sabha as per the amended provisions enshrined u/r 4 (1) (f) of the ST & OTFDs (Recognition of Forest Rights) Amendment Rules, 2012.

8. Cancellation of Titles given to 5 OTFDs of Sundargarh district & action against the erring officers: As reported by the PA, ITDA, Sundargarh, cancellation of 5 Titles given to OTFDs is to be discussed in the DLC meeting scheduled to be held shortly and no compensation has been paid to any of those 5 OTFDs. However, reports about the action initiated against the erring officers should be reported to the SSD Department by 27.09.2014 positively.

9. Awareness generation on the Amended provisions in Blocks & GPs of Sundargarh District: Though the awareness generation on amended provisions of the FR Rules, 2012 in each Block & GPs of Sundargarh District has already been made, as disclosed by the PA, ITDA, Sundargarh, still he was requested to communicate the same through letter enclosing details of the programmes thereof.

(Action: Collector, Sundargarh / PA, ITDA, Sundargarh)

10. Completion of recognition of CRs & CFRRs within a time bound period:

The activities identified to be completed within the dateline fixed in the last SLMC have not been adhered to by majority of the Districts. However, information as regard collection of claims for Community Rights and Community Forest Resources Rights during the period June, 2013 to August, 2014 is to be reported in the format mentioned below by the concerned Collectors by 22.09.2014.
