**Proceedings of the meeting of the Tribes Advisory Council held in the 3<sup>rd</sup> Floor Conference Hall of the Secretariat on 11.06.2010 at 11.30 AM.**

**1.** The Tribes Advisory Council meeting was held on 11.06.2010 at 11.30 AM in the 3<sup>rd</sup> Floor Conference Hall of the Secretariat under the Chairmanship of Hon'ble Chief Minister, Orissa. The list of Hon'ble Members and Officers who attended the meeting is annexed at **Annexure-1.**

**2.** At the outset, Hon'ble Chief Minister welcomed all the members of the Tribes Advisory Council and highlighted the steps taken by State Government for the welfare of the Scheduled Tribes in the State. He requested the Members to discuss various issues Agenda-wise and put forth their valuable views on each point of the Agenda.

Principal Secretary, ST & SC Development Department then placed the Agenda items with explanatory notes for discussion before the august house.

**3.** After detailed deliberations on various items contained in the Agenda, the following decisions were taken Agenda wise unanimously:

**3.1** The reconstitution of Tribes Advisory Council vide Department Notification No. 40648 dt. 10.11.2009 was noted by the members.

**3.2** The proceeding of the last TAC held on 09.01.2009 was confirmed by the Council.

**3.3** The Action Taken Report of the decisions taken in the TAC meeting held on 09.01.2009 was placed before the Hon'ble Members for their information. It was informed to the members that a detailed circular for non-requirement of





resubmission of Caste Certificate at the time renewal of scholarship would be issued for information of School & Mass Education Department, Govt. of Orissa and Higher Education Department, Govt. of Orissa.

**3.4** It was decided that SCSTRTI will carry out a broad based study on "Putiya" Community and submit its report on the ethnic status of the Community which will be placed before the next TAC for further consideration.

**3.5** The Expert Committee Report on substitution of "Kui" with "Kui (Kandha)" at Sl.No.31 of the ST list of Orissa was placed before the Tribes Advisory Council for discussion. It was decided that before taking a final decision on the matter, there will be further wide ranging consultation by some TAC Members along with Expert Committee Members with community organizations and Collector, Kandhamal. It was further decided that their report will be placed before <sup>the</sup> ~~next~~ TAC for consideration.

**3.6** The status report on the implementation of the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 in the State was noted by the members. It was decided that all Collectors shall be instructed to give sketch map of the forest land along with RORs. It was also decided that Revenue Department will issue necessary guidelines within a fortnight for incorporation of the RORs given under this Act with revenue records. It was also decided that Collectors shall process Community Claims on priority.



**3.7** The Annual Administrative Report for 2007-2008 regarding administration of Scheduled areas was approved with the comments that a report on the achievement under various protective legislations shall be included in the report and typographical mistakes will be corrected.

**3.8** The implementation status of PESA Act in the State was noted by the members. It was decided that there will be detailed deliberations on the implementation status of each section of PESA Act with TAC Members by P.R. Department in collaboration with SCSTRTI in another State-Level workshop and the recommendations may be placed before the TAC.

**3.9.** Principal Secretary to Government, ST & SC Development Department informed the members that proposals for inclusion of "Sudho Soura", "Sudha Savar", "Sudha Saora" in ST list of Orissa have been recommended to Government of India vide ST & SC Development Department Office Letter No. 31884 dt. 30.12.1985, Letter No. 31884 dt. 30.12.1985 and Letter No. 18521 dt. 29.07.1981 respectively. It was decided that Ministry of Tribal Affairs, Government of India will be reminded in this matter.

**3.10** Principal Secretary to Government, Law Department explained to the members about the legal position for provision of reservation in direct recruitment to the post of Additional District Judge. Law Department was requested to further examine it with reference to recent Judicial

Pronouncements on this matter. It was pointed out to the members about the present provision of reservation on promotion to Class-I Posts at the lowest rung and above as per Section 4 (2) (c) of ORV Act, 1975.

**3.11** It was decided that Revenue Department will examine the provisions relating to sale of immovable property by tribals to non-tribals in other important States, discuss with TAC Members in a State Level workshop in collaboration with SCSTRTI.

It was also decided that proposed amendment of Regulation 2 of 1956 on which Presidential assent has been withheld will be re-examined and discussed with TAC Members. This will be placed again before Government of India through TAC.

**3.12** It was decided that a committee under the Chairmanship of ADC with Principal Secretary of School and Mass Education Department, Commissioner-cum-Secretary to Govt., Higher Education Department and Principal Secretary of ST & SC Development Department as members will examine the proposals of upgradation of ST & SC Development Department High Schools to +2 level and other issues relating to Education of ST students as suggested by Hon'ble TAC Member Shri Chakradhar Paik.

**4.** Hon'ble TAC Members raised various issues after discussion of agenda items. After discussion, the following decisions were taken:-





- 4.1** Application of ORV Act to contractual appointments will be re-examined by the Law Department. It will suggest ways to extend reservation in contractual appointments.
- 4.2** All backlog SC/ST vacancies of different Departments will be filled up. The concerned Administrative Departments will move Finance Department for filling up backlog SC / ST vacancies within a month.
- 4.3** All pending proposals recommended by TAC to Government of India for inclusion in the ST list of Orissa will be taken up with Govt. of India through a Government Delegation with representatives of TAC Members.
- 4.4** ST & SC Development Department will examine the necessity of notification of new Districts/ Tahsils etc.in place of undivided Districts / Tahsils as the Scheduled area as new districts and Tahsils have been created in the meanwhile in our State.
- 4.5** It was decided that ATLC through an Expert Committee will examine and submit its views to the TAC about the appropriateness of inclusion of "Ho" and "Kolha" tribal languages in Eighth Schedule of the Constitution of India.

The meeting ended with a vote of thanks to the Hon'ble Chairman and all the Members.
