2. The Principal Secretary/Commissioner-cum-Secretary, ST & SC Dev. Department shall act as Secretary *Ex-officio* of the Board. The term of the Board shall be till such period as the State Government may decide or until the desolation of the Odisha Legislative Assembly as the case may be and it shall be reconstituted soon thereafter.

3. Provided that the State Government may, by notification extend the term of the Board or may dissolve it at any time they deem expedient.

4. This will come into force with immediate effect.
