Madam,

In inviting reference to the letter cited above, I am directed to state that correction of RoRs and Maps of the forest land vested with the claimants is a statutory requirement as per the provisions provided under Rule 12A (9) and Rule 8 (f) and (g) of the amended FR Rules, 2012. In the review meeting held on 18.02.2021 under the Chairmanship of the DC-cum-ACS, Odisha, it has been decided that the Forest & Environment Department should work out a methodology and frame a process/guidelines to record & hand over Forest Pattas to the forest right title holders in respect of the forest land under it and ensure its uploading in "Bhulekh" portal as per the process adopted & Format devised by the R & DM Department, so that the FR title holders or his dependents / legal heirs do not face any problem in future. In this connection, a draft Template for Record of Rights (RoR) in respect of the FRA titles vested in the forest land under the books of Forest & Environment Department under FRA, 2006 has been prepared and attached herewith for kind consideration.

I would therefore, request you to kindly look into the matter and initiate needful action at your end so that the decision of the meeting dated 18.02.2021 is carried out into effect for the larger interest of the ST FRA title holders.
