Proceedings of the Joint Meeting on Important Issues for Implementation of FRA & Land Rights to PVTGs" held on 26.11.2020 at 3.30 PM through virtual mode

A joint meeting on "Important Issues for Implementation of FRA & Land Rights to PVTGs" was held on 26.11.2020 at 3.30 PM, wherein Principal Secretary, SSD, Principal Secretary, R&DM, Director (ST), Director, SCSTRTI, Additional Secretary, (LR & GE), R & DM Deptt., PD, OPELIP and OSD, SSD participated through virtual mode. In the meeting following agenda points were discussed & decisions taken:

- 1. <u>Demarcation & RoR corrections in respect of the titles distributed under FRA with special reference to titles distributed on Jungle Kissam forest land & distribution of certified copies of RoR to the Forest Rights title holders.</u>
 - i. Information on Tehsil wise pendency in respect of RoR correction work is to be worked out and shared with the R &DM Department for needful action.
 - ii. Issue concerning correction of RoRs in respect of "Jungle Block Kisam" forest land of Koraput district would be examined by the R & DM Department and decision would be taken in consultation with the Forest & Env. Department.
- iii. While correction of RoRs is made at the Tehsil level, it is to be ensured that the IFR titles are registered jointly in the name of both the spouses in case of married persons & in the name of the single head in case of a house hold headed by a single person, as laid down under Section 4 (4) of the FRA, 2006. Besides, the "Chauhadi" part in Col.9 of the Khataian (Schedule I Form No.39 A) also needs to be mentioned therein.
- iv. Correction of RoRs in respect of the titles distributed under FRA would be reviewed by the R & DM Department in its monthly review meetings with the Revenue Officials of the districts & expeditious steps would be taken for its early completion. The district wise status of the corrections of RoRs and demarcation made till the end of October, 2020 is attached as Annexure-1.

2. Conversion of Forest Villages/ un-surveyed settlements or habitations into Revenue villages:

- i. As per the provisions enumerated under Section 3 (1) (h) of the FRA, 2006 and the guidelines issued by the R & DM Department's letter no.3831 dt.02.0.2017, all concerned Collectors would be moved to expedite the matter by the R & DM Department. However, OSD, SSD would apprise this matter along with the district wise status in detail to the R &DM Department, on any convenient date to be fixed by the R & DM Department.
- ii. A Senior Officer well conversant with the implementation of FRA is to be designated as the Nodal Officer on FRA in the R & DM Department for coordination in all such matters / issues henceforth for its eventual solution.

3. Presence of RIs/Amins during the field verification process and providing maps to Gram Sabhas:

i. All Sub-Collectors cum Chairperson of SDLCs on FRA would be impressed upon to follow the provision stipulated under Rule 6 (b) of the FRA Amended Rules, 2012 as regard supply of village maps to the Gram-sabha or FRC concerned. They would also be instructed to follow the provision as provided under Rule 12 A (1) of the Amended FR Rules, 2012 stipulating presence of RIs/Amins during verification of the claims as well as the evidences on the site.

4. Land Rights to PVTGs:

- i. PD, OPELIP to work out the Tehsil wise & village wise details of the landless and homestead less PVTGs and submit it to the R &DM Department at the earliest possible, so that it could be taken up on priority for the well being of the most marginalized sections of the tribal society. In this regard, instructions contained in R & DM Deptt's letter no.68/CSR&DM dated 04.01.2010 may be followed. (Copy enclosed)
- ii. Similarly, Village and Tehsil wise list of PVTGs benefitted under FRA are also to be shared with the R &DM Department for needful action on the matter of correction of RoRs/Maps.

The meeting ended with a vote of thanks to all the participants.

Sir/Madam,

It has been brought to the notice of the Government that a number of applications received under the "Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006* relate to revenue non-forest land. Such applications are, therefore, being rejected by the committees constituted under the Forest Rights Act.

As you are aware, the policy of the Government Is to provide homestead land to all homesteadless persons. Surveys have been conducted under the "Vasundhara" scheme for covering all such homesteadless persons for grant of land in the past. Hence applications that cannot be considered under the FR Act, 2006 should be taken up under the relevant land laws applicable for non-forest lands.

There are provisions in the Orissa Government Land Settlement Act and the Orissa Prevention of Land Encroachment Act for settlement of Government land in favour of eligible persons. These provisions should be utilized in all deserving cases.

Hence you are directed to ensure that all eligible cases relating to non-forest land should be considered and provided Land under the OGLS Act and OPLE Act proactive following due procedure in all cases where the application under Forest Right Act are rejected on the ground that the land occupied by the applicant is not forest land.

These instructions should be brought to the notice of all Sub-Collectors, Tahsiladars, Revenue Inspectors and other field functionaries of Revenue Department for strict compliance.
