Sub:- Submission of progress on status of forest villages, un-surveyed villages and old habitations etc. identified for conversion into revenue villages as per the provisions contained under Section 3 (1) (h) of the Forest Rights Act – 2006.

Madam / Sir.

In inviting reference to the letters cited above, I am to state that the Schedule Tribe and Other Traditional Forest Dwellers (Recognition of Forest Rights Act) 2006, recognize and vest the rights of settlement and conversion of all forest villages, old habitation, un-surveyed villages in forest, whether recorded, notified or not into revenue villages under Section 3(1)(h) of the Forest Rights Act,2006. To facilitate proper identification, district-wise data of such settlements/ habitations numbering about 589, as derived from the 2001 Census, have already been shared with all the districts vide this Department's Memo dated 08.05.2014. The Revenue and D. M. Department vide its letter dt. 02.02.2017 has also issued guidelines detailing the process to be adopted for conversion of forest villages etc. into Revenue villages. But the information received from the district level Nodal Officer on FRA through the MPRs indicates very poor progress in majority of the districts. DC-cum-ACS, Odisha had expressed his serious concern in this matter in course of the review meeting held on 18.02.2021 and has directed to obtain detail information on status and progress made in this concern.

I would therefore, request you to furnish information indicating the progress made for conversion of such forest villages, old habitation, un-surveyed villages etc into Revenue villages in the format attached herein as **Annexure-1** through email: stscfra@gmail.com and rajkdbbsr@gmail.com by 08.03.2021 positively for needful action at this end.
