Sub: - Review of rejected Individual Forest Rights (IFR) claims under the Forest Rights Act, 2006 in compliance to the affidavit filed in the Supreme Court of India in Writ Petition (C) No. 109/2008.

Ref :- This Department's letter No. 7984/SSD dt.29.04.2019 No.13581/SSD dt.08.08.2019 & D.O. letter No. 1386/ SSD dated 20.01.2020 of the Chief Secretary, Odisha addressed to all Collectors.

Madam/ Sir,

You are aware that the Chief Secretary, Odisha has filed a compliance affidavit in the Supreme Court of India in WP(C) No.109/2008 (Wildlife First & Others Vrs Union of India & Others) on 05.07.2019 wherein submission has been made for completion of review & disposal of all pending rejected IFR claims (1,27,620 IFR claims) under FRA within 9 months and the same has expired during March,2020. But the review & disposal of those IFR claims in majority of the districts have not been completed. DC cum ACS, Odisha while reviewing the implementation of FRA on 18.02.2021 has expressed his deep concern over the matter and has directed to identify the reasons of non-adherence of the instructions of the government by the Collectors concerned conveyed vide letters referred above and call for the details of the action plan as well as the time line for completion of the process of disposal of rejected IFR claims. District wise pendency data, as on 31.12.2020, is indicated in the statement attached as Annexure- I and it shows that 87,706 numbers of claims are still pending for review & final disposal by the DLCs concerned. It has also been decided that review of this matter would be taken up on fortnightly basis by this Department and its progress would be reported to the DC cum ACS for needful action at his end.

I would therefore, request you to consider the gravity of the matter and prompt action for disposal of the pendency shown against your district may immediately be taken up and compliance be reported to this department. Besides it, as pointed out above, reasons of non-adherence of the instructions of the government conveyed earlier along with action plan & time line for its completion needs to be submitted to this department by 10.03.2021 positively through e-mail for needful consideration at this end.

This may please be treated as **MOST URGENT**.
