Sir/Madam,

I am directed to inform that on scrutiny of the MPRs on FRA being submitted by the district level Nodal Officers, it is noted that the Community Right (CR) claims & Community Forest Resources (CFR) Right claims filed under FRA, 2006, though approved by the DLCs since long, are not being distributed to the claimants concerned (Gram-sabha/villages), thus resulting in severe accumulation of the pendency year after year. A statement attached herein as **Annexure-I** reveals that though the total pendency of CR & CFR claims as on 30.09.2018 was 1,541, it went up to 1,674 on 30.09.2019 and on 31.10.2020, it stands at 2,816. Such non-distribution of the approved titles by the DLCs concerned is against the letter & spirit of this benevolent Act and violates the provisions enumerated under Rule 12 B (3) of the Amended FR Rules, 2012.

I would therefore, request you to look into the matter personally and ensure distribution of those pending CR & CFR titles to the claimants concerned, which have been duly approved by the DLC on FRA of your District. The entire exercise of distribution of those approved titles needs to be completed by 31.01.2021 and compliance be reported to this Department by the 10.02.2021 positively
