Sub:- Non-coverage of FRA beneficiaries under various schemes & programs of the Government through convergence mode.

Madam/Sir,

In inviting reference to the letters on the subject cited above, I am directed to state that the details of FRA title holders benefitted through convergence of Government Schemes and programs in a prescribed format was sought vide this Department's letters referred above. Though few districts (Angul, Balasore, Bargarh, Bhadrak, Bolangir, Deogarh, Dhenkanal, Gajapati, Ganjam, Jagatsinghpur, Jajpur, Jharsuguda, Keonjhar, Rayagada and Sambalpur) have submitted the same but the Aadhaar number along with the contact number of the title holders concerned, if any, is now being required and the same may please be provided in Col.11 (Remarks) of the said format. This matter also came up for discussion in the review meeting held under the Chairmanship of the DC-cum-ACS, Odisha on 18.02.2021 it was decided that a detailed database of FRA title holders assisted under various schemes and programs is to be worked out, so that need assessment of each title holders could be made with the involvement of good & credible NGOs/CSOs at the district or sub-district level.

I would therefore, request you to consider the matter and please furnish the requisite information (in Excel format) in the prescribed format attached herewith as **Annexure-A** to this Department at the earliest possible through email-id: stscfra@gmail.com and rajkdbbsr@gmail.com for further action at this end.
