# <u>Proceedings of the meeting on important issues on FRA held on 30.06.2020</u> <u>at 4 PM under the Chairmanship of the Principal Secretary, SSD.</u>

A meeting to discuss five important issues on FRA, 2006 was held on 30.06.2020 at 4 PM in the Conference Hall of the SSD Department under the Chairmanship of the Principal Secretary, ST & SC Dev. Department. List of Members present in the meeting is attached as **Annexure-1**.

Gist of the discussions made & decisions taken on the five agenda points are indicated below:

# 1. <u>Violation of the provisions of FRA, 2006 & Forest (Conservation) Rules as</u> <u>amended during 2017, while diverting forest land for non forest purposes.</u>

Special Secretary, Forest & Env. Department stated that the diversion proposals in both the cases were processed as per Form-1 prescribed by the MoEF & CC, Govt. of India for linear projects through its guidelines circulated vide letter dt.28.03.2019, which do not incorporate the requirement of consent of Gram-sabha, as prescribed in Para (b), (c) & (d) of Form–II prescribed for projects other than linear projects. Director, SCSTRTI & Director, ST were of the view that the provisions of FRA also needs to be complied, as prescribed therein. Further discussions held were inconclusive and it was decided to have next round of discussions on the same issue after going through the detail Project Proposals and Formats submitted by the Collector, Sundargarh.

## 2. <u>Finalisation of the contents of the Counter Affidavit to be filed in WP (C)</u> no.13579 of 2018 on behalf of the State of Odisha.

It was decided to finalise the contents of the Counter affidavit in WP (C) no.13579 of 2018 after the next meeting, as indicated above.

# 3. Forcible Plantation on forest land vested with the claimants under FRA, 2006.

Special Secretary, Forest & Env. Department stated that instances of such forcible plantation on the forest land vested with the claimants, if any, may immediately be communicated to them and they would certainly look into it.

#### 4. Transportation of MFPs by the right holders-issuance of TT permits

It was decided that the de-regulation made in respect of 6 GPs of Kalahandi district during the year 2017 could be extended for the FRA title holders of Kalahandi district after submission of detailed proposal in this concern and after due approval of the Government.

#### 5. <u>Non-distribution of CFR titles already approved by the DLCs due to non-</u> signing of the FRA titles by the DFOs concerned:

DFOs concerned of the seven districts would be moved by the Forest & Env. Department so as to expedite signing of the pending 730 CFR titles duly approved by the DLCs concerned, as per the statement attached as **Annexure-II.**
