Dear Madam,

- Alleged violation of the provisions of the Scheduled Sub: Tribes & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (FRA, 2006) and Amendment Rules, 2012 in the matter of transportation of MFPs by the Forest Rights title holders.
- Ref .:- (i) This Department's letters bearing No.10217/SSD dated 05.08.2020 and 17450/SSD dated 09.12.2020 (Copies enclosed). (ii) Letters dated 18.03.2021 of the DFO, Bhawanipatna (KL) Forest Division addressed to 26 Gram-Sabhas of Kalahandi district.

In inviting reference to the correspondences on the subject cited above, I am to state that despite our request made vide this Department's letter dt.05.08.2020 for issuance of necessary instruction to the DFOs concerned not to harass any genuine forest right title holders to enjoy the community rights conferred under FRA and to recognise the authority of the Gram-Sabha in the sale, disposal & trading of MFPs, it is noted that DFO, Bhawanipatna (KL) Division has issued notices to 26 Gram-sabhas of Kalahandi district with copies to the Chairman, SLMC (FRA) cum Chief Secretary, Odisha & others, which indicates that he has not yet been made aware about the correct position of law thus putting the FR title holders in adverse position affecting their livelihoods.

In this connection, I would like to draw your kind attention to the provisions enumerated under rule 2 d of the amended Forest Rights Rules, 2012, which has also been reiterated vide Notification No.24314/F&E dt.28.12.2012 of the Forest & Environment Department in the matter of system of working of bamboo in forests by the State Government by providing that "Transit permit will be issued by the Gram Sabha for which permit books will be supplied by the Forest Department free of cost".

In view of it, I would request you to kindly consider the gravity of the matter and instruct the DFO concerned accordingly so that forest right title holders are not put to undue harassment in the trading of MFPs during this critical juncture and are provided with the requisite hand holding support as critical juncture $\frac{1}{23}$ envisaged under rule 16 of the amendeu rotet. Madam,

In inviting reference to the subject cited above, I am to inform that petitions are being received from several Gram-Sabhas /villagers of Kalahandi district with the allegations that field functionaries of Forest & Environment Department are obstructing the sale and disposal of MFPs and insisting the forest right title holders to furnish Transit Permit. In this connection, I would like to submit that Section 3(1) (c) of the FRA, 2006 recognizes right of ownership, access to collect, use and dispose of MFP, which has been traditionally collected within or outside village boundaries. Rule 2 (d) of the amended FRA Rules, 2012 also provides that the transit permit regime in relation to the transportation of MFP shall be modified & given by the Committee constituted under clause (e) of sub-rule (1) of rule 4 or the person authorized by the Gram-Sabha. Aforesaid rule also stipulate that the transportation of MFP within and outside forest areas for use or sale could be done through appropriate means of transport, though prior to the amendment, 2012, the means of transportation was specified only through head-loads, bicycle and handcarts. Thus, the forest right title holders vested with Community Rights can now use any means for transportation of MFPs and legally they cannot be restrained/obstructed from doing so, since interference with the enjoyment of forest rights of STs/SCs has been included as an offence under Section 3 (g) of the SCs & the STs (Prevention of Atrocities) Act, 1989, as amended.

I would like to add that similar petitions relating to six villages of Golmunda Block of Kalahandi district were also reported to your Department during the year 2017 vide letter referred above and Govt. after due consideration was pleased to deregulate the trade of Kendu leaves in respect of those six villages of Kalahandi only vide Notification no. 23717/F&E dated 17.11.2017. This issue was also discussed in the meeting dated 30.06.2020, wherein Spl. Secretary of your Deptt. had suggested to communicate such instances to the Department for needful action. Accordingly, the details of such grievances/petitions received in this Department is attached herein, which may kindly be referred to for better appreciation of facts

In view of the above noted facts & circumstances, I would request you to kindly consider the matter & issue necessary instruction to the DFOs concerned, so that the authority of the Gram-Sabha for issuance of Transit Permit for transportation of MFPs is recognized and the forest right title holders under FRA are not put to unnecessary harassment in the sale, disposal and trading of MFPs, which is an important source of their livelihood and acts as a solace during this critical period of Covid-19 pandemic.

Sir,

This is to inform you that petitions have been received from around six Gram Sabhas of Golamunda Block in Kalahandi district wherein it is alleged that the field functionaries of the Forest & Environment Department namely the, DFO, Kendu Leaf Division, Bhawanipatna is obstructing the sale and disposal of the Kendu Leaf which was collected legitimately by the community from within the assigned forest areas, based on Community Forest Rights vested with these Gram Sabhas. Copies of the petitions along with copies of the Community Forest Rights titles issued to these Gram Sabhas are enclosed herewith.

Perusal of these Community Forest Rights titles clearly indicate that the Community Rights have been given for collection of minor forest produce including Kendu Leaf, its use, sale and disposal. As the State Government under Section 3 (1) (c) of 'The Schedules Tribes & Other Forest Dwellers (Recognition of Forest Rights) Act, 2006' have conferred the right of ownership, access to collect, use and dispose of Kendu Leaf from the designated forest areas as specified in the Community Forest Rights titles, any obstruction in carrying out the rights of these Right holders is in complete violation of the provisions of the Act. Further any authority or an officer who contravenes with the provisions of the Forest Rights Act shall be liable to be proceeded against Section 7 of the Forest Rights Act.

Hence, you are requested to issue necessary instructions to the field functionaries Forest & Environment Department not to obstruct any genuine right holders or community to enjoy the Community Rights conferred to them under the provisions of Forest Rights Act.

This is utmost priority.
