Sub : Reopening of Schools for Students of Class/ Standard-I to XII for the Academic Session 2021-22.

Ref : Order No.817/R&DM(DM) Dt.03.02.2022 of SRC, Odisha.

Sir,

On the subject cited above and pursuant to the orders mentioned under reference and to say that Government have been pleased to allow reopening of Schools of all Educational Institutions as the Covid-19 positive cases and Omicron cases are in decreasing trend in Odisha. The details of the school opening and conduct of examination for different classes are detailed below ;

1. All the Educational Institutions from Class/ Standard-VIII onwards) will start physical class room teaching **w.e.f. 07.02.2022.**
2. Classes from Class/ Standard-I to Class/ Standard-VII will reopened **w.e.f. 14.02.2022.**
3. For the current Academic Year, students in schools including Higher Secondary Schools can avail the option of Online/ Offline/ Hybrid Teaching for their classes.

4. Hostels and other residential facilities are also allowed to be opened up from the date of Offline classes begins.
5. All Covid appropriate protocol i.e. physical distancing may be followed to the extent possible.

CONDUCT OF EXAMINATION :

1. Examinations for Classes upto Class/ Standard-IX and for promotion of students from Class/ Standard-XI to Class/ Standard-XII will be done through Class Assessment. Students may be allowed the option of taking the examination either through Offline or Online or Hybrid mode depending upon the feasibility of the schools. Detailed instructions will be issued subsequently.
2. Examinations for Class/ Standard-X and Class/ Standard-XII will be conducted as per the orders and guidelines of BSE, Odisha/ CHSE, Odisha/ CBSE, New Delhi/ ICSE.

The respective Directors will be facilitating introduction of Bridge Course to help the students to overcome the learning gaps and all efforts should be made by the Institutions to assist/ hand hold/ counsel the children and their parents to cope with the situation.

This guidelines/ SOP will be applicable to all Educational Institutions (Government, Government Aided, Privately managed English & Odia Medium Schools) coming under the administrative jurisdiction of School & Mass Education Department.
