**RESOLUTION**

**Sub : Enhancement of rate of Pre-matric Scholarship for the ST/SC students pursuing their studies in the schools of SSD Dept. as well as S & ME Department.**

Pre-matric Scholarship is given to the Scheduled Caste & Scheduled Tribe students reading in different educational institutions of ST & SC Development Department as well as School & Mass Education Department including Special ST/SC hostels of ST & SC Development Department.

Monthly rate of pre-matric scholarship of ST & SC boarder as well as Day Scholar students was last enhanced vide this Department Resolution No. 12417 Dated 22-06-2015 and subsequent corrigendum no.13206 dated 04-07-2015 w.e.f. 22.06.2015.

Due to considerable rise in prices of food articles and other essential commodities of daily use, existing rate of pre-matric scholarship is found inadequate to meet the maintenance of boarders. Considering the inadequacy of the existing rates of Pre-matric Scholarship given to the SC/ST Boarder students, Government after careful consideration have been pleased to enhance the rates of pre-matric scholarship in respect of boarders. The enhanced rate of pre-matric scholarship as per details given below will be effective from the **date of issue of this resolution** until further orders :

In case of boarders of Class IX -XII of Educational Institutions under the administrative control of ST & SC Dev. Deptt. & S & ME Deptt., an additional rice of 250 gm will be allotted per day per boarder at the subsidised rate for providing an additional meal during Mid Day Meal time. The cost of the additional allotment of subsidized rice will be provided by the ST & SC Dev. Dept. over and above the usual entitled scholarship amount. This has been concurred in by the Finance Department in their File No. FIN-SOS2-BT-0007-2022.

\* In order to address the nutritional intake of the boarders Ragi based food item such as Ragi malt and Ragi laddoo will be provided in the breakfast and evening snacks menu of the boarders.

Government Resolution No. 12417 Dated 22-06-2015 and corrigendum no.13206 dated 04-07-2015 are hereby superseded. This Resolution has been concurred in by Finance Department in their File No. FIN-SOS2-MEET-0005-2011.




