- 4)The candidates applying for the above mentioned posts must fulfill the following eligibility criteria under the Right to Information Act, 2005 and Right to Information (Amendment) Act, 2019.
- I. The candidate shall be a person of eminence in public life with wide knowledge and experience in law, science and technology, social service, management, journalism, mass-media or administration and governance.
- II. The candidate shall not be a Member of Parliament or Member of the Legislature of any State or Union Territory, as the case may be, or hold any other office of profit or connected with any political party or carrying on any business or pursuing any profession. It is clarified that cessation/termination of holding of office of profit,

Or

pursuing any profession or carrying any business is a condition precedent to the appointment of a person as State Information Commissioner.

- III. Those who have already attained the age of 65 years as on the date of issue of this advertisement shall not be eligible to be considered for applying this post.
- 5) The willing applicants those who had applied earlier in response to both the advertisement issued vide advt. no-13698 dated 02.12.2021 and advertisement issued vide advt. no 12075 dated 05.11.2021 should apply afresh for the two posts before the stipulated date.
