2. The Committee reconstituted herewith will be effective from the date of issue of this Notification.

3. The State Level Monitoring Committee shall:

- a) devise criteria and indicators for monitoring the process of recognition and vesting of forest rights;
- b) monitor the process of recognition, verification and vesting of forest rights in the State;
- c) meet at least once in three months to monitor the process of recognition, verification and vesting of forest rights, consider and address the field level problems, and furnish a quarterly report in the prescribed format to the Central Government on their assessment regarding the status of claims, the compliance with the steps required under the Act, details of claims approved, reasons of rejection, if any and the status of pending claims.



d) on receipt of a notice as mentioned in Section 8 of the Act, take appropriate actions against the authorities concerned under the Act.

e) monitor resettlement under Sub-Section (2) of Section-4 of the Act.

f) specifically monitor compliance of the provisions contained in (m) of sub-section (1) of section 3 and sub-section (8) of section 4.

ORDER: Ordered that this Notification be published in the extra-ordinary issue of the Odisha Gazette and copies thereof be sent to all Departments of Government / All Heads of Department/ All Collectors / All Sub-Collectors at the earliest.




