Proceedings of the 10th SLMC meeting on Forest Rights Act, 2006 on implementation of Forest Rights Act, 2006 held on 01.11.2022 at 4 PM

The 10th State level Monitoring Committee (SLMC) meeting on implementation of the Scheduled Tribes & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 was held on 01.11.2022 at 4 PM in the 2nd Floor Conference Hall of the Loka Seva Bhawan under the Chairmanship of Chief Secretary, Odisha. The list of members present in the meeting is enclosed at **Annexure-1**.

Commissioner cum Secretary, ST & SC Development Department welcomed all the Members and thereafter, requested the Officer on Special Duty, SSD Department to initiate the discussions, agenda wise. After thorough discussions, following decisions were taken:

1. The proceedings of the 9th SLMC meeting held on 07.03.2017 communicated to all Members vide letter No.5641/SSD dt.16.03.2017 of the ST & SC Dev. Department was approved.
2. Action taken reports on the decisions of the 9th SLMC, para wise, were discussed in detail and approved.
3. Status of compliance of the submissions made before the Hon'ble Supreme Court of India in WP (C) No. 109/2008.

The Committee observed that 3,662 numbers of rejected claims are still pending for disposal in 06 districts.

The Committee emphasized that those pending rejected claims need to be dealt as per the procedures laid down under the amended rules and should be disposed of in a time bound manner. District wise details and the status is attached as **Annexure-2**.

During discussion the Committee was appraised that Hon'ble Supreme Court vide its Orders dt.13.02.2019 & dt.28.02.2019 has directed FSI to carry out satellite survey of the rejected claims and place on record the encroachment position as far as possible.

Accordingly, details of 13,851 claims rejected at the DLC level prior to filing of affidavit have been submitted to the PCCF, Odisha and eventually to the FSI. Forest Department has a geo-referenced data-base of the forest land under its jurisdiction but no such data are available for the forest land in the books of R & DM Department.

However, requisite information needs to be collected from the concerned districts and submitted to proper quarters for needful action at their end. This information is to be collected and collated in time bound manner.

(Action: Revenue & DM Deptt./ Forest, Env. & CC Deptt./ All Collectors)

4. Recognition of Individual Forest Rights (IFR), Community Forest Rights (CR) and Community Forest Resources Rights (CFR).

Committee was appraised about the latest status (Details in **Annexure-3A and 3B**) and after its thorough review, it was decided that expeditious steps need to be taken by the concerned districts for early disposal of all the claims pending at different levels and also for filing of community rights claims as per the potential indicated in the FRA Atlas prepared by the SCSTRTI, Bhubaneswar and shared among all concerned.

Hon'ble MLA, Lanjigarh raised the matter of problems being faced by the Community Forest Right holders in transportation of MFPs in Kalahandi district. It was decided that since the Gramsabhas (GSs) vested with the community rights titles are authorized under the Act, so the officials of the Forest, Env. & CC Department should extend support to GSs in its assessment and development of sustainable resource management plans.

(Action: Revenue & DM Deptt./ Forest, Env. & CC Deptt./ All Collectors)

5. Demarcation & correction of Record of Rights (RoRs) and Maps of the forest lands vested with the claimants.

Till the end of September, 2022, demarcation and record corrections of the titles vested with the claimants have been made in respect of about 4,05,187 (88%) and 2,70,432 (58%) titles respectively (District wise status is attached as **Annexure-4A** and **4B**).

Forest, Env. & CC Department through its Office Memorandum dated 01.11.2022 has also issued guidelines for correction of records of the titles vested in the reserve/protected forest.

Some Members expressed concern on reports from field that title holders are not aware about the exact boundaries of the forest land vested with them and in many cases sketch maps have not been attached with the titles.

Committee emphasized that this issue needs to be taken up by the field functionaries of concerned Departments and the process of record corrections should be completed preferably within 03 months for all the titles issued in revenue as well as reserve category forests.

(Action: Revenue & DM Deptt./ Forest, Env. & CC Deptt./ All Collectors)

6. Conversion of forest villages, old habitations, un-surveyed villages etc. into revenue villages.

Forest Rights Act, 2006 provides for conversion of all forest villages, old habitations, un-surveyed villages and other villages in forest lands, whether recorded, notified or not into revenue villages. In this concern, R and DM Department has issued a detailed procedural guideline on 02.02.2017. In the meantime, 458 such habitations/villages have been identified in 22 districts, out of which 14 have been converted into revenue villages through Notifications by the Director, Land Records and Survey, Cuttack. It was noted that 76 such proposals of Ganjam and Malkangiri districts duly approved & submitted by the DLCs concerned have been returned by the DLR & S, Cuttack with minor objections. It was decided that its re-submission needs to be expedited along with those pending in respect of other districts. District wise status is indicated at **Annexure-5**.

(Action: Revenue & DM Deptt./ Forest, Env. & CC Deptt./ All Collectors)

7. Recognition & vesting of Habitat Rights of PVTGs.

SCSTRTI with the support of Ministry of Tribal Affairs, Govt. of India had conducted a research study on "Determination and Mapping of Habitat Rights of the PVTGs under FRA" and in the process it had provided handholding support to the traditional institutions of the PVTGs for filing of Habitat claims of 9 PVTG communities. Those Habitat claims have been processed up to the SDLC level.

Committee suggested for early recognition of such rights by following due procedure of law.

(Action: All Collectors/ SCSTRTI, Bhubaneswar)

8. Coverage of all FRA title holders under various schemes and programs of the Govt.

FRA title holders are being provided livelihood support activities in convergence with various schemes like IAY/PMAY, Mo Kudia, Mo Pokari, MGNREGA, National Horticulture Mission, National Bamboo Mission, Mission Jeevika etc. District wise status of coverage, as on 30.09.2022, is indicated at **Annexure-6**.

The Committee observed that there needs to be continued support for all the IFR title holders for land development, creation of irrigation potentials, promotion of farm forestry and horticulture activities etc., so that livelihood of the title holders are improved & strengthened. This should be closely monitored by the respective PA, ITDAs in the Scheduled Areas and PD, DRDAs in the non-Scheduled Areas.

(Action: All Collectors/PR & DW Deptt./ Agriculture & FE Deptt./PA, ITDAs)

9. Issues pertaining to VSS & CFRMC (Community Forest Resource Management Committee)


Committee was appraised that FRA endorses management, protection and conservation rights with the GS vested with the title under Section 3 (1) (i) of the Act. Committee suggested that after due recognition of CFR rights, the rights of protection, management and conservation ought to be entrusted with the Committee constituted by GS under rule 4 (1) (e) of the amended FR Rules, 2012. For its better functioning, it was decided that the existing members of the GSs, who have experiences with the management practices of forest resources due to their associations with the JFM movement may be adopted as members of that Committee. Forest, Env. & CC Department will extend necessary support in this regard.

(Action: Forest, Env. & CC/PR & DW Deptt.)

10. Hon'ble MLA, Lanjigarh also raised the issue of difficulties being faced by the FR title holders in selling of paddy under MSP operations. In this connection, it was shared that Food Supplies and Consumer Welfare Department has already issued instruction to all Collectors with copies to concerned authorities vide letter dated 20.03.2017 (Copy enclosed as **Annexure -7**). The Committee resolved that necessary instructions to the concerned officials should be issued by the FS & CW department, so that those instructions are followed scrupulously at the field level. Steps may also be taken for massive sensitization at the ground level.

(Action: Food Supplies & CW Deptt./All Collectors)

Madam/ Sir,

I am directed to say that in the State Level Monitoring Committee Meeting to review the implementation of Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 held on 7.3.2017 under the Chairmanship of Chief Secretary, it was brought to the notice of Government that in some cases, individuals who have been given patta under Forest Rights Act (FRA) are not able to sell their paddy under MSP operations.

In order to obviate the above difficulties it is hereby directed that during the process of online registration of farmers for selling surplus paddy to Government the FRA patta shown by farmers shall be taken into account by PACS/LAMPCS officials. If the land details given by such farmers are not available in Bhulekh they may be verified through verification by Revenue Inspectors from their records.

Tribal farmers are a vulnerable group and their cases have to be dealt with extreme sensitivity and this Department desires that no such farmer who is willing to sell his surplus paddy to Government is denied of the facility under any circumstances.

I would, therefore, request you to sensitize the Co-operation/Revenue/Food Supplies field officials in your district and ensure that Forest Rights Pattas issued in favour of beneficiaries are taken into account at the time of online farmer registration and marketable surplus
