Applications are invited from interested retired Group-B or above Officers of Government of Odisha, who are eligible as per conditions mentioned below for engagement of **05(Five)** Nos. of Officer on Special Duty(OSD) on contractual basis for a period of 01(one) year against the vacant post of Assistant Section Officer in the Commerce & Transport (Transport) Department in pursuance of guidelines enshrined in G.A. Department Resolution No 23750/Gen, dated 27.08.2014, Finance Department O.M. No. 7022/F, dated 17.03.2018 & O.M No. 24533/F, dated 29.09.2022.

Eligibility Conditions:

1. The retired persons who have retired from Govt. Service on attaining the age of superannuation and below the age of sixty five years having good service records and are physically fit shall be eligible to be considered for re-engagement.
2. The retired employees against whom departmental proceedings or criminal cases are contemplated /pending or who have been penalized for misconduct during the period of five years preceding the retirement may not apply.
3. The engagement will be initially made for a period of 01(one) year which may be extended by further period of two years with spells of one year each subject to satisfactory performance up to a total period of three years not beyond the age of sixty-five years of age in any case or till the posts are filled up by regular process whichever is earlier. The competent authority reserves the right to terminate the engagement at any time by giving one month written notice. On the contrary, if any re-engaged employee desires to resign, he/she shall do so by giving one month's written notice to the competent authority.
4. The period of engagement shall not be counted as Government Service for the purpose of pension and any other retirement benefits and the engaged employees will be subject to and will abide by the provisions of Odisha Government Servants' Conduct Rules, 1957 and shall be liable to be proceeded against for their misconduct, omissions and commissions as per the provisions under the Odisha Pension Rules, 1992.
5. The willing retired Group-B employee or above fulfilling all the criteria may apply in the enclosed format along with copies of required documents to the undersigned and application should reach the undersigned by **5.30 PM dtd.03.06.2023.**
