RESOLUTION

Sub: Declaration of Laikera and Kirimera Blocks of Jharsuguda District as Integrated Tribal Development Agency (ITDA) of Odisha

After considering the proposal of State Government, the Ministry of Tribal Affairs(MoTA) GoI have declared Laikera and Kirimera Blocks of Jharsuguda District as TSP Block and constitution of 23rd Integrated Tribal Development Agency (ITDA) of Odisha for the purpose of Tribal Sub Plan vide their letter No. F. No. 11014/01/2018- C&LM (e-11603) dated 24th November 2022 in order to reduce regional disparities and bring out a perceptible improvement in the quality of life of the people inhabiting in this area.

In pursuance to the aforementioned decision of the Union Government, State Govt. have been pleased to decide that

1. A society namely "Integrated Tribal Development Agency, Jharsuguda" shall be registered under Societies Act, 1860 having a Governing Body consisting of following members.

2. All the villages coming under Laikera and Kirimera Blocks shall be included in ITDA, Jharsuguda.

- The Governing Body shall have such administrative and financial power as the State Govt. vests in them from time to time. The Governing Body will be concerned with the Grants-in-Aid to be placed at the disposal of the ITDA from various sources.
- 4. The Head Quarters of the ITDA will be at District Head Quarter of Jharsuguda District until further orders.
- 5. The ITDA will receive funds from State Govt., Govt. of India and other sources and formulate and implement different programmes for integrated development of the area with the focus on tribal population as per the guide lines issued by the Central Govt. as well as by the State Govt. from time to time.
- Project level Committee of the ITDA , Jharsuguda may be constituted as per the Resolution No. 27189 dt. 7.9.2000 of ST & SC Development Department For effective and expeditious implementation of the various programme in the ITDA , to ensure proper and timely utilisation of funds and to maintain effective coordination between the sectorial authorities in the field .
- 7. There will be a Project Administrator, a Special Officer, an Asst. Executive Engineer (Civil), an Assistant Engineer (Civil) and other support Staff to be appointed on deputation by the State Govt.
- 8. Modified Area Development Agency functioning in Laikera and Kirimera blocks of Jharsuguda District is hereby abolished from the list of MADAs of the state.
- 9. This Resolution will come into force from the date of issue of Notification .
- 10. This has been concurred in by Finance Department in their file No-- FIN-SOS2-ESTT-0028-2022 and P & C Department in their file No-- PC-PRGII-MISC-0013-2023 .
