In accordance with the provisions contained under sub-sections (1) and (2) of section 4 of the Juvenile Justice (Care and Protection of Children) Act, 2015 read with rules 3 and 105 of Odisha Juvenile Justice (Care and Protection of Children) Rules, 2018, the Juvenile Justice Boards in respect of Kalahandi district is reconstituted for exercising the powers and to discharge the duties conferred on such Board in relation to children in conflict with law as prescribed under the Act and the Rules framed thereunder.

- 2. The appointment of any member of the Board, except the Principal Magistrate, may be terminated after holding an inquiry by the State Government, as stipulated under sub-section (7) of section 4 of the Act, if she/he —
- (i) has been found guilty of misuse of power vested under this Act; or
- (ii) fails to attend the proceedings of the Board consecutively for three months without any valid reason; or
- (iii) fails to attend less than three-fourths of the sittings in a year; or

- (iv) becomes ineligible under sub-section (4) of section 4 of the Act during his term as a member.
- 3. The Board shall function as a Bench and shall have the powers conferred by the Code of Criminal Procedure, 1973 (2 of 1974) on a Judicial Magistrate of First Class.
- 4. The Board shall meet at such times and shall observe such rules in regard to the transaction of business at its meetings, as may be prescribed.
- 5. This Notification is in supercession of all previous Notifications/ Office Orders relating to the constitution of Juvenile Justice Board in respect of the Kalahandi district. The tenure of the committee shall be for a period of 3 years from the date of notification i.e., until 25.6. 2026.
